



# All-City Swim Championship 2026 – Entries Timeline and Information

## Entry Process Highlights:

- Standard entry period is on Sunday, July 26, 2026 from 8:00 AM CT – 9:00 pm CDT
- Swimmers must have competed in three (3) All-City League dual meets during the 2025 season in an individual event. Meet Management will conduct checks on eligibility using the All-City results database. Note: invitational meets do not count towards this requirement.
- Entries will be accepted virtually at <https://7xscoring.com/meets/all-city-2026/>
  - Enter in all individual events and all relays teams with seed times on Sunday 7/26
  - Enter relay only swimmers in event 201 or event 202
  - Relay names are required for 8 under medley relays and 8 and under freestyle relays
  - **NEW FOR 2026: for 9-10, 11-12, 13-14, and 15-19 Relays - only enter relay teams that will have four legal swimmers in Events #3-10 and #63-70. For relays without four legal swimmers, enter them into exhibition events #103-110 and #163-170.**
  - All other relay names are due 3 hours after the conclusion of the meet on Friday 7/31
  - Seed times should be in SCY. Any non-SCY times will automatically be converted to SCY.
  - Proof your entries during your warm-up time and stop by to see Austin to sign-off
  - Ensure only Unified swimmers are entered in the unified events
  - For 15-19 year olds: if choosing to swim fly or IM, they can only enter into one distance of these strokes (i.e. 50 fly OR 100 fly; 100 IM OR 200 IM)
  - Email, call or text if you have any questions/issues
- Splash fees should be brought during your warm-up period
- **Psych sheets will be posted late on July 26.** Report any issues ASAP. Note that seed times cannot be changed (unless error by meet management) after the initial entry deadline.
- **This meet is designated as a USA Swimming Observed meet.** This means that times from the meet can be entered into SWIMS if the swimmer completes an observation request form and submits the administrative payment at <https://7xscoring.com/all-city/observation/> by July 29, 9 pm CT.

## Scratching from Finals:

- You must report scratches from finals to the Administrative Referee or an Administrative Official within 30 minutes after the end of the session in which the preliminary swim was conducted.
